Terms

Context is published in the United Kingdom by the Association for Family and Systemic Psychotherapy (AFSP) whose registered office is at Exec 6, 7 & 8, The Causeway, Wilderspool Causeway, Warrington, Cheshire. WA4 6PS

Accessibility

Context is published and distributed solely by AFSP and can only be purchased via the AFSP website.

By submitting an order through theafsp.org you signify your understanding of the following Terms and Conditions and of the AFSP [Data Policy](#).

1. Ordering your Copy of or Subscription to Context

1a. Submitting your order through theafsp.org

By submitting an order through theafsp.org.uk you are making an offer to the AFSP to order or subscribe or buy Context. Confirmation of receipt of your order will be done by AFSP by email within 24 hours of purchase but is not confirmation that your offer to subscribe or buy has been accepted by the AFSP. The AFSP will subsequently contact you separately by email or by post to confirm or refuse your order, in most cases within 2 weeks of submitting your order on the website. The AFSP may accept or reject your offer at its discretion. If you do not receive confirmation from the AFSP please contact us through our [Contact us form](#).

1b. Your contract with AFSP

No contractual obligations will arise until your offer to subscribe, or buy is confirmed to you by the AFSP.

2. Use of your data by AFSP

Any data AFSP may collect about you while using the website shall be dealt with in accordance with its [Data Policy](#). By submitting an order through the website, you agree that your email address may be used by the AFSP to send you service communications by email relating to your order and a market research survey related to your order experience.

The AFSP, will handle your data according to their own Privacy Policy. The AFSP, will use the data you provide when submitting your order through the website to process and set up your order or subscription, and for delivery. If you select to pay by Direct Debit, the AFSP shall also use your data for the setup and processing of Direct Debit payments. If you have provided consent to receive marketing correspondence from the AFSP you have purchased through the website, your data will be used for the specific purposes to which you consented.

3. Prices

Unless stated otherwise, prices quoted on the website include delivery charges and taxes (where applicable). If there has been a mistake in the price offered on the website, AFSP may contact you to confirm whether you wish to subscribe or buy at the correct price. 4. Credit Card, Debit Card or PayPal payments

5. Direct Debit payments

If you select to pay by Direct Debit, the Direct Debit mandate and contract will be between you and the AFSP.

6. Delivery of Context
